NATIONAL JUTE BOARD

Scheme updates under National Jute Development Programme (NJDP) – An umbrella scheme for Promotion and Development of Jute Sector approved for implementation during 2021-22 to 2025-26 (15th Finance Commission period)

In consonance with the mandates, National Jute Board has been implementing various schemes / programmes for overall development / promotion of jute sector starting from agriculture to finished products. The approved schemes implemented under National Jute Development Programme (NJDP):

Updates during 2021-22 and 2022-23 (April to September 2022), are given below:

(a) Improved Cultivation and Advanced Retting Exercise (Jute ICARE)

NJB has been implementing a project Jute-ICARE (Improved Cultivation and Advanced Retting Exercise) for the last seven years in a phased manner. The project is being implemented by NJB in association with Jute Corporation of India Ltd. (JCI) and Central Research Institute for Jute & Allied Fibres, (CRIJAF), Ministry of Agriculture. The project introduces package of scientific methods of jute cultivation and retting exercises for improving fibre quality and productivity and reducing the cost of jute production and increasing farmers' income. The scientific methods include (i) Registration of farmers (ii) Supply of certified seeds, seed driller, nail weeder and CRIJAF Sona, sending SMSs and demonstrating usages of modernized tools retting exercise etc. Physical progress of Jute-ICARE are as follows: -

- 170 jute growing blocks.
- 189483 hec land.
- 420309 jute farmers.
- CRIJAF SONA for Retting: 700 M. Tons
- Certified Jute Seeds: 192 M. Tons

The project resulted in improving jute agriculture in the following manner : -

- Increased in jute production (yield) from existing 22/23 quintals per hectare to 26/28 quintals per hectare.
- Quality upgradation at least one grade high.
- Increase in farmers' income by approximately Rs 10,000/- per hectare due to production and quality improvement.
- (b) Capital Subsidy for Acquisition of Plant & Machinery (CSAPM) for manufacturing Jute Diversified Products and to facilitate modernization / upgradation of the existing Jute mills and MSME JDP Units. Target set: Incentive @ 30% of the cost of machinery facilitating investment of Rs 10,000 Lakh in acquisition of new machineries for production of JDPs by 100 Jute Mills/MSME-JDP Units at total financial outlay Rs 30.00 crore. During 2021-22, NJB received applications from 10 Jute Mills/MSME-JDP Units for acquisition of new machineries and submitted LOI under the scheme. During 2022-23 5 claim applications were received and are under examination.
- (c) Jute Resource cum Production Centre (JRCPC) to spread jute diversification programme by providing trainings to new artisans and WSHGs for sustained employment for production of JDPs. Target set :150 JRCPCs, 10,800 new employment. During 2021-22, 8 JRCPCs collaborating agencies were engaged are imparting training under the scheme, 192 new jute artisans trained, products :woolenised jute carpets, braided items and novelty gift items, jute bags. During 2022-23 16 applications are received and under process.
- **(d) Jute Raw Material Bank (JRMB)** to supply jute raw materials to jute artisans, MSMEs for production of JDPs at Mill Gate price. Target set: 140 JRMBs. During 2021-22, 21 JRMBs collaborating agencies were engaged under the scheme. During 2022-23, 9 applications have been received and under process.
- (e) Jute Retail Outlets (JRO) Scheme To facilitate existing and new artisans / entrepreneurs for promotion and sale of JDPs through Retail Outlets / Showrooms. Target set: 140 Jute Retail Outlets. During 2021-22, 13 retail outlets were opened by the jute entrepreneurs under the scheme. During 2022-23, 01 application has been received and under process.
- (f) Jute Design Resource Centre (JDRC) for designing and development of market worthy innovative jute diversified products and helping existing and new JDP manufacturers and exporters. Target set: 580 designs of innovative lifestyle jute products. NIFT has been approached with deliverables to confirm.

- (g) Production Linked Incentive (PLI) Scheme Jute Mills and MSME JDP units exporting JDPs are being supported for manufacturing and exporting jute diversified products and making them cost competitive in the international markets. Target set:550 JDP manufacturing units are to be provided incentive under the scheme. During 2021-22, NJB received 50 applications amounting to Rs.319.34 lakh and settled 30 claim applications amounting to Rs 240.14 Lakh under the scheme. During 2022-23, 15 applications have been received and under process.
- **(h) Jute Mark Logo** As approved by the Ministry of Textiles, Govt of India, Jute Mark India Logo has to be promoted and used by the manufacturers / exporters of Jute Products to ensure quality compliance representing percentage of jute in the blending process. The Logo has to be issued by an accredited organization like Textiles Committee, Mumbai. The logo has been unveiled by Secretary (Textiles) on 9thJuly, 2022 at Kolkata.

(i) Market Development Promotion activities (Domestic & Exports) : During 2021-22 :

- Organised 24 nos. domestic fairs with 540 jute units / beneficiaries.
- Organised participation in 2 international fairs with 07 registered jute exporters

During 2022-23

30 nos. jute fairs facilitating 600 jute units and 3 international fairs/events with 15 exporters organised.

(j) Scholarship Scheme for the girl children of the workers of jute mills, JDP-MSMEs: NJB provided education support to the girl children of the workers of Jute Mills/MSME-JDP Units in the form of incentives @ Rs.5,000/- on passing out Secondary Examination and Rs.10,000/- on Higher Secondary Examination under the scheme. During 2021-22, NJB released scholarship amounting to Rs 316.35 Lakh to 4404 girl children of the workers of Jute Mills / MSME-JDP Units. During 2022-23, NJB received 3483 applications from 34 jute mills amounting to Rs.248.95 lakhs which are under process.
