After detailed discussion on the above price-list and w.r.t the machine invoices under the claim of M/s Times Fibrefill Pvt. Ltd., it was decided that it would be prudent to follow the precedence in this regard already existing in the MoT decided by the Competent Authority of MoT. It is found that in a similar case it was decided by the TAMC in the Textiles Commissioner's office that 15% of the machine cost is considered as cost of the spares of the claimed machines as per the approved minutes of the 14th TAMC meeting held on 25.09.2019 under A-TUFS. Accordingly, the Committee advised NJB to re-calculate the maximum eligible price of the claimed machine/s for inclusion in the approved price-list.

Revised recommendation of eligible vendor for enlistment:

The status of De-novo process was elaborately discussed in the meeting. Further to the 11 nos. of vendors (foreign & indigenous) enlisted in the 7th Technical Committee (TC) meeting held on 19.06.2023, 1 more following vendor is considered by the Committee as enlisted under the Scheme.

✓ Miscellaneous issues:

a. Matter related to the M/s Times Fibrefill Pvt. Ltd. (CSAPM file no.: 46):

The matter was discussed at length and the price list w.r.t. the invoices under the claim were intensively scrutinized by the Technical Committee.

After detailed discussion, it was decided that it would be prudent to follow the precedence in this regard already existing in the MoT decided by the Competent Authority of MoT. It is found that in a similar case it was decided by the TAMC in the Textiles Commissioner's office that 15% of the machine cost is considered as cost of the spares of the claimed machines as per the approved minutes of the 14th TAMC meeting held on 25.09.2019 under A-TUFS. Accordingly, the Committee advised NJB to re-calculate the maximum eligible price of the claimed machine/s for processing the claim further.

Moreover, it was also observed that the vendor supplied one more machine named as "Fabric Un-winder" to M/s Times Fiberfill Pvt. Ltd. cost of \$5,500.00 and which was subsequently claimed under CSAPM is not included in the price-list submitted by the vendor. It was directed that such claimed machine/s could not be considered as eligible under the Scheme which is/ are not listed in the price-list submitted by the vendor.

The Committee advised NJB to process the claim based on the above direction.

b. Matter related sanction of loan of M/s ECO Jute Pvt. Ltd. (CSAPM file no.: 37):

The issue of credit link of the claimed machines not before the date of claim submission is not accepted by the Committee.

c. Matter related sanction of loan of M/s Gloster Ltd. (CSAPM file no.: 48):

After assessing the fact, the Committee proposed that since the machine details are mentioned in the DPR which was submitted by the claimant to the Bank for loan, Bank Appraisal Note and also the date of loan sanctioned before the date of claim submission, the matter may be considered.

The Chairman approved the proposal and directed NJB to process the claim accordingly.
