The meeting was Chaired by the Jute Commissioner. On behalf of NJB, Dr. Mahadeb Datta, Head (Tech.) welcomed all the attendee members. Thereafter the agendas were taken up for discussion. The list of attendees present physically and virtually is enclosed at Annexure – I.

Agenda 1: Confirmation of the Minutes of the 9th Technical Committee under CSAPM held on 26.09.2023

The minutes of the 9th Meeting of the Technical Committee under CSAPM held on 26.09.2023, after being duly approved by the Chairman, were circulated to the members vide NJB's communication no. NJB/CSAPM/9thTC-Minutes/2023-24/10207-13 dated 03.10.2023.

Since, no further correspondence received in this regard, the minutes have been considered as approved by the Committee.

Agenda 2: Action Taken Report on 9th Technical Committee (TC) meeting

The Committee noted the actions taken as per direction of the 9th TC meeting.

Agenda 3: Matter related to De-novo Registration under CSAPM

Recommendation of eligible vendor for enlistment:

The status of De-novo process was discussed in details during the meeting. Further to the 12 nos. of vendors (foreign & indigenous) enlisted during the previous Committee, based on the recommendation given by the Textiles Committee, 3 more following vendors are considered by the Committee as enlisted under the Scheme.

Request received from M/s IIGM Pvt. Ltd. to enlist another machine under the Scheme:

The matter was discussed in length, since the said vendor is already empaneled under the Scheme, the Committee advised Textiles Committee to consider the matter for further course of action.

After due-deliberation, it was proposed by the Committee that the maximum basic cost of the machine manufactured by the foreign manufacturer / authorized agent of foreign manufacturer shall be basic cost (FOB value excluding Freight and Insurance charges) in foreign currency.

The Chairman approved the proposal.

It was also suggested by the Committee that for the interest of the Industry similar cases may be taken-up by the Textiles Committee under intimation to NJB and may revised the price-list and the revised price-list which can be ratified subsequently by the Technical Committee later on towards smooth implementation of the Scheme.

The Chairman approved the proposal in-principle.

Revised Price-List:

The revised price-list forwarded by the Textiles Committee vide mail dated 20.03.2024 has been approved by the Committee. The Chairman advised NJB to publish the same in www.jute.com

Proposal received regarding inclusion of Machine (Core & Non-Core) under the Scheme:

The proposal for inclusion the following machines involved for production "Jute Leaf Tea" a newly developed technology by ICAR-NINFET under Non-core eligible machinery list of the Scheme has been approved by the Chairman.

Further, it was proposed by the Committee that such kind of proposal for inclusion machines under Non-Core category involved toward commercialization of newly developed technology / product through JPDS Scheme under NJDP of NJB may be approved in-principle by the Committee.

After due-deliberation, the Chairman approved the proposal in-principle towards giving support to commercialize new technology being developed by various R&D project implemented through NJB and extend support to interested entrepreneur / start-ups.

✓ Miscellaneous issues:

Matter related to the claims submitted by M/s S.L. Packaging Pvt. Ltd. (NJB-08-SLP-24082022-49) and M/s Eco Jute Pvt. Ltd. (NJB-08-ECO-29082022-50):

Both the matter were discussed extensively during the meeting and based on the proposal submitted by Vice-Chairman, JPDEPC, it was decided that further 1 month timeline has given to the both the Unit to complete the due processes, failing which the claims sill be stand rejected without any further intimation to the Unit.

 Another matter of short receipt of subsidy against the "JUKI BAR TACKING MACHINE" supplied by M/s IIGM Pvt. Ltd. was raised by the Industry Association during the meeting.

Subsequently, it was informed by NJB that it was occurred due to typographical error in price submitted by the concerned vendor during preparation of price-list. However, the matter has been taken-up by the said vendor and the price has already amended in the price-list accordingly.

The Chairman advised that a request letter may be submitted by the concerned Claimant and the short payment may be calculated and processed by NJB after obtaining a revised TAR from Textiles Committee.

There being no other issues, the meeting ended with a vote of thanks to and from the Chair.
